## Notification of intention to cease bingo sessions

IMPORTANT INFORMATION

## Notification of intention to cease conducting bingo sessions

If a community or charitable organisation intends to cease conducting bingo, whether permanently or for a period of three months or more, the Victorian Gambling and Casino Control Commission (the VGCCC) must be notified in writing within seven days of ceasing. Where sessions of bingo are conducted on behalf of a community or charitable organisation by a bingo centre operator, the bingo centre operator is responsible for notifying the VGCCC.

## False or misleading information

It is an offence under the Gambling Regulation Act 2003 (the Act) to give information that is false or misleading. If you give false or misleading information, you may be prosecuted and fined up to 60 penalty units. The current value of a penalty unit can be obtained at <a href="mailto:vgccc.vic.gov.au">vgccc.vic.gov.au</a>

**Note:** There is **no** fee payable to notify the VGCCC of the intention to cease conducting bingo sessions.
