# Application to vary bingo rules

# Important information

#### Application to vary the rules of bingo

A community or charitable organisation or a bingo centre operator may apply to the Victorian Gambling and Casino Control Commission (the Commission) for approval to vary the rules of bingo that would otherwise apply to the organisation or operator. If the Commission approves a variation, the organisation or operator must comply with the rules as varied.

#### The Commission may require notification of bingo rules

The Commission may, by written notice, require an organisation or operator to notify patrons of the rules that apply to the conduct of a session of bingo. The Commission may require notification of the rules to be made:

- by displaying notices in the form and manner specified by th Commission
- by making announcements in the form and manner specifie by the Commission.

#### False or misleading information

It is an offence under the Act to give information that is false or misleading. If you give false or misleading information, you may be prosecuted and fined up to 60 penalty units.
