Option 4: Nomination - Registered Bookmaker

Under section 4.5.2 of the *Gambling Regulation Act 2003* (the Act), if an applicant for registration as a bookmaker is a corporation, the board of directors must nominate, a natural person to be approved by the Victorian Gambling and Casino Control Commission (the VGCCC) to be responsible as the registered bookmaker on behalf of the corporation. A person nominated and approved as a nominee is liable under the Act as a registered bookmaker in respect of the corporation.

- when a new nominee is required to replace a former nominee (e.g. as a result of the resignation or dismissal of a nominee or if the previous nominee has ceased to be responsible as licensee in respect of a registered bookmaker).
